

## **RENEWAL REQUIREMENTS MAY VARY**

- Know your renewal schedule
- Know how many hours of continuing education (CE) or continuing professional development (CPD) is needed for renewal
- Know any required categories of CE/CPD that must be completed for renewal
- Know how many hours of CE/CPD are required in special categories
- Know what format the CE/CPD must be in







#### **CE/CPD REQUIREMENTS AT RENEWAL**

73.3% of respondents require that a portion of a psychologist's CPD/CE hours be in Ethics.






#### **CE/CPD NUMBER OF HOURS OF ETHICS REQUIREMENTS AT RENEWAL**
