



# Education

## Psychological Associate


Most respondents indicated that a master's degree is the minimum educational requirement for licensure as a **psychological associate**, with **91%** of jurisdictions requiring at least a master's degree and **9%** requiring a doctoral degree. Most respondents (**82%**) also require regional accreditation, while **18%** do not. Additionally, **32%** of responding jurisdictions include a residency requirement as part of their standards.

20 respondents require a minimum of a master's degree, and 2 require a doctoral degree.

### Regional Accreditation




Eighteen respondents (**82%**) require regional accreditation, and four respondents (**18%**) do not.

### APA/CPA Accreditation





# Supervised Experience

## Psychological Associate

Among respondents with a **psychological associate** license type, **32%** accept practicum hours toward licensure, while four jurisdictions indicated that practicum hours are not applicable. Internship experience is more commonly required, with **41%** of respondents requiring internship hours, **18%** accepting them, and **9%** identifying other alternatives. Postdoctoral experience is the least common at this level, with only **18%** of respondents requiring it for licensure.


### Internship



# Examinations

## Psychological Associate

Among respondents with a **psychological associate** license type, **77%** require the EPPP (Part 1-Knowledge), and only **9%** require the EPPP (Part 2-Skills). Half of respondents (**50%**) require a jurisprudence examination assessing laws and regulations related to practice, while **18%** include an oral examination as part of their licensing process.



# License Renewals

## Psychological Associate


Among respondents with a **psychological associate** license type, 36% renew their licenses annually, while 32% renew every two years. Only 5% renew every three years, and another 5% follow an alternative renewal schedule.



# Inactive Licenses

## Psychological Associate


Approximately 53% of respondents provide for an inactive license status. A **psychological associate** who holds a license may not practice psychology but may continue to use the title "**psychological associate**". A **psychological associate** who holds an inactive license continues to be subject to the statutes and rules/regulations of the psychology licensing board.



# Continuing Professional Development & Continuing Education


## Psychological Associate

Continuing education (CE) requirements for **psychological associate** licensee's vary across jurisdictions. Among the 22 respondents, CE expectations range from **10** to **50** hours, most commonly set at **20** or **40** hours per renewal period. Requirements also differ by renewal cycle, with some jurisdictions mandating hours annually (e.g., 20-40 hours per year) and other every two years (e.g., 24-50 hours per two years). Two respondents indicated alternative CE requirements outside the standard annual or biannual structures, reflecting the diversity of continuing education standards among jurisdictions regulating psychological associates.




# Ethics Requirements
